NYC RING Update

AHRQ PBRN Conference

This past spring Diane McKee and Stacia Maher attended the AHRQ National PBRN Research Conference meeting in Washington, DC. The AHRQ PBRN meeting provided an opportunity for PRBR staff from around the country to share their successes and failures and to learn from colleagues. Workshops addressed best-practices, operations, information technology, quality improvement, and research methodology within PBRNs. The plenary speaker for the meeting was Paul Thomas from the UK. He discussed the benefits and drawbacks of the different ways in which PBRNs can be organized. Dr. McKee also gave a presentation on the adoption and implementation of the FLAIR project. Mental Health Task Force

We recently formed the NYC RING Mental Health Task Force in order to increase collaboration among NYC RING sites and create a mechanism for initiating small projects related to mental health and primary care. The first meeting took place this past June. Members met by conference call to define a direction toward collaborative activity that we hope will eventually improve the mental heath care provided at NYC RING sites and lead to funded projects. The group discussed current mental health projects that are taking place within NYC RING and brainstormed about ideas for small projects. Some of the ideas included finding out what happens to patients after they are screened for depression, the utilization of counseling referrals, and assessing mental health services that are co-located with health centers and those that are not co-located with health centers.

Since the first meeting, the task force has decided to expand a mental health needs assessment in the form of a brief card study that physicians will be asked to fill out on 10-15 consecutive patients. The card study was origi-

Spotlight on Fellows

NYC RING is pleased to announce that Susan Rubin, MD, MPH was awarded the Empire Clinical Research Investigator Program (ECRIP) Fellowship. Dr. Rubin will be working closely with Dr. McKee over the next two years on various research projects regarding reproductive health. Her main focus will be assisting Dr. McKee with the formative research for a large intervention to increase the provision of confidential care and STI testing in adolescents. She also hopes to analyze data from a recent survey she completed with women undergoing first trimester abortions in the primary care setting, and to begin a new study on the use of IUDs by family physicians.

Dr. Rubin completed her medical degree at the University of Pittsburgh School of Medicine and her residency at the Beth Israel Family Practice Residency Program in New York City. Following her residency, she completed the Family Planning Fellowship with Dr. Marji Gold at Montefiore as well as a Masters of Public Health degree at the Mailman School of Public Health at Columbia University. During her fellowship, Dr. Rubin conducted research on the acceptability and desirability of the provision of early abortion services in urban family medicine clinics. Dr. Rubin has worked as a primary care physician at Fordham Family Practice in

the Bronx, in a high school clinic in Washington Heights, and continues to work as an abortion provider and trainer of family medicine residents at Planned Parenthood of New York City. She has traveled abroad extensively and worked in El Salvador on a project that explored adult and adolescents attitudes about teenage pregnancy.

ECRIP is a program sponsored by the New York State Department of Health. The program encourages teaching hospitals and Graduate Medical Education (GME) consortia to train physicians as clinical researchers to advance biomedical research in New York's academic health centers. Funds from the GME Reform Incentive Pool in each region are dedicated for this program to fund clinical research positions. Request for fall 2008 applications will be posted in spring 2008. nally developed and conducted by Joanna Dognin, PsyD and other members of the "Mental Health Workgroup" at the Family Health Center. As it did at the Family Health Center, the card study will carefully document the mental health need and current access to services at different NYC RING member sites throughout the Bronx and Manhattan. In addition, demographics and physicians' perceived barriers to care will be collected. We are currently revising the card and preparing IRB applications to conduct the study at health centers within Montefiore, Bronx Lebanon, Jacobi Medical Center and the Institute for Urban Family Health.

P4H Innovators Meeting

Representatives from the FLAIR team, co-principal investigators Diane McKee and Darwin Deen and program coordinator Stacia Maher, attended the Prescription for Health (P4H) Innovators Meeting in Colorado Springs this past spring. NYC RING was one of ten PBRN's across the nation funded by the Robert Wood Johnson Foundation's Prescription for Health Program. Our project, Family Lifestyle Assessment of Initial Risk (FLAIR) assessed whether a brief practice-based initiative could be effective in producing meaningful lifestyle change among families of young children. We reframed the two year old well child visit to enhance the focus on family lifestyle risk assessment and behavior change by: 1) identifying family risk behaviors as a routine part of preventive care for 2 to 3 year olds; 2) targeting brief evidence-based behavior change messages to coincide with parents' concerns; 3) training clinicians in a patient-centered approach to help families set behavior change goals; and 4) extending clinicians effectiveness by providing access to a lifestyle counselor, trained in culturally sensitive behavior change counseling. Participating practices were Tremont, Castle Hill, Fordham, Marble Hill, University Ave. and West Farms.

The P4H Innovators Meeting gave the ten funded PBRN's an opportunity to come together in person to discuss their findings. Most of the meeting was devoted to hearing about the ten projects' preliminary results and to foster continued discussion among the ten projects. The National Program Office and the analysis team also provided updates and opportunities for discussion about the common measures that were collected from all of the projects. Dr. McKee gave a presentation of the preliminary results of the FLAIR project. We are currently in the final stages of data collection for the FLAIR project and will begin final analysis of the data soon. We plan to disseminate our results to the sites that participated in the project and the NYC RING community this fall. We also plan to publish the results from the FLAIR project in peer reviewed journals.
